This advisory is being issued by quashing earlier issued advisories regarding PET Scan (MG098A) by SACHIS: -

1. Letter ABPMJAY/Letter-Advisory/2022-23/1953 dated on 30.12.2022 (Related to tie up with Diagnostic Centres),
2. Letter ABPMJAY/Letter-431/2023-24/796 dated on 09.05.2024 for rates of PET SCAN (as per KGMU) and,
3. Point No VI (a) and VI (b) of Letter-Advisory/2025-26/Lucknow/765 regarding frequency of PET Scan

with the following updated instructions:-

- I. EHCPs are not allowed to book PET Scan (Code MG098A) as **Standalone** on TMS 2.0.
- II. As diagnostic centres are not directly empanelled under PMJAY, EHCPs without PET scan facilities shall tie up through MoU with such centres; however, only the treating hospital can claim the prescribed package amount along with relevant photographs of patients and of diagnostic centre.
- III. For PET Scan payment will be done as per KGMU rates i.e., Rs **10,450/-**
- IV. **In Metastatic Conditions** -PET Scan should be allowed only after 03 months of active treatment, and if PET Scan is performed on same patients **before** three months it shall be clearly justified by the treating/referring doctor.
- V. **In Non-Metastatic Conditions:** PET Scan should not be given more than once a year.

- V. **In Non-Metastatic Conditions:** PET Scan should not be given more than once a year.
