This document has been prepared for guidance of PROCESSING TEAM and TRANSACTION MANAGEMENT SYSTEM of AB PM-JAY for the claims of procedures mentioned above. The hospitals can also refer to this document so that they have the insight on how the claims will be processed. However, this document doesn't provide any guidance on clinical and therapeutic management of patient. In that respect the hospitals and physicians may refer to any other relevant material as per the extant professional norms.

#### **PART I: GUIDELINES FOR CLINICIANS AND HEALTHCARE PROVIDERS**

##### **1.1 Objective:**

The purpose of this section is to act as a guidance & a clinical decision support tool for the clinicians in deciding the line of treatment, plan clinical management of patient and decide referral of cases to the appropriate level of care (as required) for treatment of patients under PMJAY and selection of corresponding Health Benefit Package.

It will also serve as a tool for hospitals to determine and submit the mandatory documents required for claiming reimbursement of health benefit package under PMJAY.

##### **1.2 Clinical key pointers:**

Proceed with **Hypospadias repair** only if diagnosis made is backed by clinical manifestation

- Opening of the urethra at a location other than the tip of the penis
- Downward curve of the penis (chordee)
- Hooded appearance of the penis because only the top half of the penis is covered by foreskin

- d. Abnormal spraying during urination

**Follow-up visit:** Usually after a week of the Hypospadias repair surgery. Purpose is to remove stunt (If applicable) and examine any infection and progress post-surgery.

### 1.3 Mandatory documents- For healthcare providers

Following documents should be uploaded by the concerned hospital staff at the time of pre-authorization and claims submission:

a. Clinical notes of current visit detailed history, signs & symptoms, indication for procedure	Yes
b. Discharge Summary of last admission for Hypospadias repair surgery	Yes
<b>ii. At the time of claim submission</b>	
a. Detailed clinical notes/discharge summary of current visit	Yes
b. Post procedure USG / UFM / Urine Routine report	Yes

### **PART III: GUIDELINES FOR TRANSACTION MANAGEMENT SYSTEM (TMS)**

**3.1 Objective:** To enable setting up of cross check mechanisms/rule engines within the IT platform (TMS) to ensure compliance with STGs and to prevent fraud / abuse of the Health Benefit Package.

**3.2 Below mentioned are the scenarios where a provision would be built in TMS for pop-ups:**

Hypospadias Repair - Follow Up:

- I. Did physical examination detect structural abnormalities or ventral penile curvature? Yes

Till the time the functionality is being developed, the processing doctors shall check the above manually.
