#### Disclaimer:

For monitoring and administering the claim management process of **Comprehensive medical rehabilitation for complication of secondary to specified disability/multiple disability including procedures, Chemo denervation with or without orthosis** for NHA shall be following these guidelines. This document has been prepared for guidance of PROCESSING TEAM and TRANSACTION MANAGEMENT SYSTEM of AB PM-JAY for the claims of procedures mentioned above. The hospitals can also refer to this document so that they have the insight on how the claims will be processed. However, this document doesn't provide any guidance on clinical and therapeutic management of patient. In that respect the hospitals and physicians may refer to any other relevant material as per the extant professional norms.

### PART I: GUIDELINES FOR CLINICIANS AND HEALTHCARE PROVIDERS

**Objective:**

The purpose of this section is to act as a guidance & a clinical decision support tool for the clinicians in deciding the line of treatment, plan clinical management of patient and decide referral of cases to the appropriate level of care (as required) for treatment of patients under PMJAY and selection of corresponding Health Benefit Package.

It will also serve as a tool for hospitals to determine and submit the mandatory documents required for claiming reimbursement of health benefit package under PMJAY.

**Clinical key pointers:** Rehabilitation is defined as “a set of interventions designed to optimize functioning and reduce disability in individuals with health conditions in interaction with their environment. Rehabilitation is an essential part of universal health coverage along with promotion of good health, prevention of disease, treatment and palliative care. Rehabilitation helps a child, adult or older person to be as independent as possible in everyday activities and enables participation in education, work, recreation and meaningful life roles such as taking care of family.

**Rehabilitation for disability/multiple disability:**

- Physical therapy
- Occupational therapy
- Speech therapy
- Respiratory therapy
- Cognitive rehabilitation
- Vocational rehabilitation
- Neurorehabilitation
- Physical therapy
- Occupational therapy
- Social skill training
- Psychotherapy
- Therapy for cognitive disorders.
- Therapy for communication disorders
- Noninvasive brain stimulation

**Chemo denervation with or without orthosis:** Chemo denervation is an attractive option for the management of limb spasticity. A local injection is used to manage the focal muscle overactivity while minimizing systemic side effects. Botulinum toxin, phenol and alcohol are commonly used as chemo denervation agents.

## PART II: GUIDELINES FOR TRANSACTION MANAGEMENT SYSTEM (TMS)

**Objective:** To enable setting up of cross check mechanisms/rule engines within the IT platform (TMS) to ensure compliance with STGs and to prevent fraud / abuse of the Health Benefit Package.

**Below mentioned are the scenarios where a provision would be built in TMS for pop-ups:**

- Does past history of patient, treatment records & diagnostic reports suggestive of rehabilitation treatment? Yes/No

Till the time the functionality is being developed, the processing doctors shall check the above manually.
